As you know, the WCA continues to move forward. As a group, we are committed to advocating for the interests of injured workers and their right to representation. With the November election only a few months away and a change of administration only weeks after that, we must be visible, vocal and involved if we are to be effective on behalf of our constituency.

As you have seen, we have renewed our use of the WCA blog, and you can expect to see a regular stream of posts taking positions on the issues which concern us. The WCA Board is scheduled to meet with our lobbyist, Richard Winsten of Meyer, Suozzi, English & Klein next week, and we hope to issue a report about that meeting and an announcement about several upcoming WCA events shortly thereafter.

The WCA is a political action committee, and to achieve political action, we need funds. We need you to renew your financial commitment to the WCA. I have attached a copy of the membership application, which outlines the various membership levels. If you contribute \$300 per month and are approved by a majority of the Directors on the WCA Board, you can join the Board and help choose the direction of the organization. At \$200 per month, your firm will appear (or continue to appear) on the WCA web site with a link to your firm’s web site. As the WCA web site is highly visible to internet search engines, this may significantly enhance your own internet presence and visibility. For \$100 per month you can be listed (or continue to be listed) on the WCA web site without a link. And for only \$50 per month you can be a member of the WCA and support our political efforts.

We know that you may have heard from another group that was started by a few individuals who chose to withdraw from the WCA. You should know that the WCA Board remains intact and fully supported by firms in active practice, as it has been for the past five years.
